

A&E Inc. Social Media Giveaway Rules

Please review the terms and conditions appearing below before submitting an entry and participating in the Social Media Giveaway (“Giveaway”). When submitting entries Participants agree to accept and be bound by all the terms and conditions set forth in these rules. DO NOT PARTICIPATE in the Giveaway if any disagreement or ineligibility exists.

Sponsor

Purchase

No purchase necessary. Purchase will not improve chances of winning.

Giveaway Period

Sponsor may conduct any Giveaway during any timeframe without any given notice.

Eligibility

Giveaways are open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico, to those 18 years of age and older (“Participant”). Employees, officers, and directors of the Sponsor and its affiliates, subsidiaries, independent representatives, and franchisees, and members of the immediate family (spouse, children, parents, or persons living in the same household) of the above are ineligible. Participant agrees to these Official Rules and will be disqualified if they do not meet conform. Void where prohibited.

Odds

Entry

Participants must perform the designated social media platform action to be considered during the giveaway (the “Entry”)

Winning

Participants submitting a valid entry will be entered into a random drawing. Drawing will occur on the designated date and time determined by the Sponsor. Once the potential winner's eligibility is verified, the prize will be awarded to the winner ("Winner). If the winner can not recognize or accept the prize for any reason, the prize will be forfeited and another winner selected by a random drawing.

Restrictions

No substitution for prizes. If Winner can not accept the prize, it will be forfeited and another winner selected. All federal, state, and local taxes on any prize will be the responsibility of the winner. Winner must provide a valid physical/digital address for prize to be issued.

Notification and Claim

The potential Winner will be notified within 30 days of the drawing. Winners, by accepting the prize, certify they are eligible to win.
